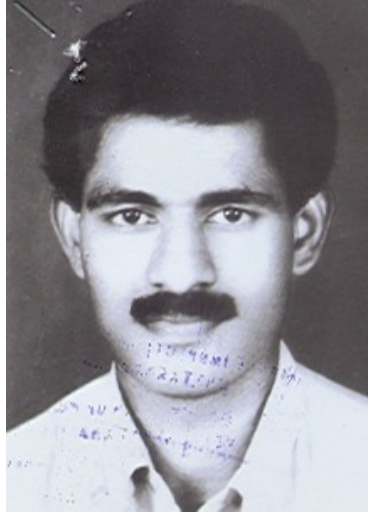

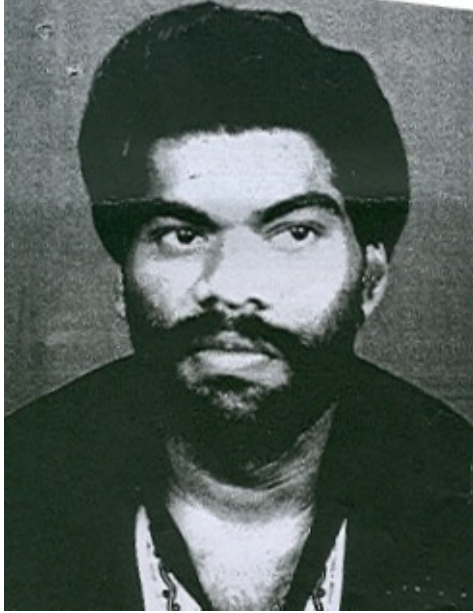

Cherambadi PS, Cr.No.163/01 U/s 451, 468, 420, 409, 120(b), 109 & 34 IPC

Between 11/9/2001 and 9/10/2001 the accused illegally trespassed in the Cherambadi Telephone Exchange of BSNL, secured access to the protected computer systems, forged the electric records of the computer and made ISD, STD and Local calls and caused a loss to the tune of Rs. 2,75,863/- to the BSNL. On the complaint of the S.D.O, Telephones, BSNL, Gudalur, a case was registered on 7/11/2001 and investigated by the Deputy Superintendent of Police, Devala Sub Division, Nilgiri district. During the course of investigation Abdul Rahim Mullu and three others were arrested and remanded to Judicial Custody. As per the Orders of the Director General of Police, Tamilnadu, the case was transferred to CB CID, Coimbatore for further investigation. During the investigation by CB CID accused Ismail @ Mohamed Ismail and four others were arrested and remanded to Judicial Custody. Final report was filed on 28/4/2005 against all the 9 accused and the case was taken on file in PRC Bo.8/2005 on 9/6/2005 by the Judicial Magistrate, Gudalur. Accused, Ismail @ Mohamed Ismail fail to attend the Court from 28/10/2005, NBW was issued against him and pending execution. Action against the sureties was taken on 15/11/2006. Sincere efforts taken to execute the NBW ended in vain. Confidential enquiry reveals that the accused Ismail @ Mohamed Ismail gone to a Gulf country through a fake passport.

Wanted Persons

On 11/7/1996 night at the retiring room of Railway station, Ooty the accused Ms. Omana Edadan murdered one Muralidharan by injecting poison. The body was cut into pieces, packed in suitcases and tried to dispose off by the accused at Kodaikanal. The above case was registered, investigated and the charge sheet was filed in the Court of the Judicial Magistrate, Ooty on 15/6/1998. This case was taken on file in PRC No.2/1998 on 31/12/1998. Thereafter, the accused unnecessarily drag the trial for want of copies in Malayalam or English. The accused, Omana Edan was absconding from 29/1/2001. The Court issued Non Bailable warrant against the sureties and sincere efforts taken to execute the Non Bailable Warrant ended in vain. The Court declared her as proclaimed offender on 2/6/2004 and the notification was published in all the leading Tamil and Malayalam dailies. Red Corner Notice was also issued by INTERPOL through CBI, New Delhi.
