
NOTIFICATION

Sealed and Competitive Quotations are invited by the under signed for the year 2010-2011 from Driving Schools having valid license/valid certifications from the Motor Vehicles Department, specifying the rates (per trainee) for deputing training staff with vehicles and equipments of the Driving Schools for imparting instruction in driving to Recruit Police Constables, who are undergoing training at Kerala Armed Police 2nd Battalion (Trainees).

TERMS AND CONDITIONS

- (1) Quotations should be from Driving Schools, having valid licence/valid certifications from the motor vehicles department, valid licence/valid certificates should attach along with the quotations.
- (2) Quotations without valid licence/valid certifications from the motor vehicles department will be rejected from the first scrutiny itself.
- (3) The rate of training for getting motor cycle driving licence and light motor driving licence (Car/Jeep) may be separately quoted.
- (4) Instructions should be imported as per the syllabus prescribed under the Motor Vehicle Act and Rules.
- (5) It will be necessary to depute properly qualified staff with properly certified instructional vehicles, training equipments, POL and accessories to the Battalions/Academy for the purpose of imparting the above training and no remuneration. Otherthan the quoted rate will be given for this.
- (6) The rate per trainee will be given only, if the trainees pass in the licensing test conducted by the Motor Vehicle Department.

7. Training will have to be given at the times and places as may be decided by the Commandant, KAP 2 Bn., Muttikulangara(PO) Palakkad District.
8. The Commandant, Kerala Armed Police 2 Bn. will have the authority to stop the training by instructors from one Driving School or engage instructors from other Driving School at any time in order to ensure either the quality of training or the timely completion of training or the maintenance of proper discipline during training.
- (9) The Commandant KAP 2 Bn. will have the authority to cancel the training conducted by any School without assigning any reason.
- (10) The instructors deputed by School will be treated as guest facility and are under the general control of the Commandant or of such authority as may be specified by the Commandant.
- (11) The lowest rate quoted will be accepted and the rate to be fixed and thereafter any qualified Driving School is, that are prepared to conduct the training at this rate will be entrusted with the work of imparting training. The excess work load beyond the assessed capability of one Driving School will be entrusted to the qualified staff of other driving schools limiting payment to the lowest rate accepted.
- (12) The last date and time for receipt of quotation is at 12.00 Noon on 1.7.2010. Opening of the quotations is at 3.00PM on 1.7.2010.
